Our Process

1. A Tow analyst reviews the case, determining unnecessary charges or inflations, and creates an analysis of the bill. Tow analysts are experienced in tow procedure, often managing or working at a tow company prior.
2. The analysis is then collated into a report that we send to local counsel or one of our Directors of Litigation. This report provides mediators a strong informed stance from which to dispute charges.
3. Should mediation not provide a suitable reduction, Morgan, Cohen & Bach can launch an investigation into the tow company. Working with local authorities and reviewing past tows by the business can provide mediators new options during negotiations.
4. If after investigation we still cannot reach an agreed price reduction, we offer to file suit that can lead to a writ of replevin, placing your equipment in the hands of authorities instead of the tow company, or judgements enforced on the business.

Advantages of Our Service

1. **Ready at a Moment's Notice** - Our team starts working on a case the moment it is received. All we require to open a case is some basic information about your tow.

Our Rates

Morgan, Cohen & Bach calculates our fee based on our performance in negotiation. We charge 25% of the total amount you see reduced from your tow bill. For example, if a tow company charges you \$5,000.00 for a job and we negotiate the total down to \$2,000.00 then our fee would total at \$750.00.

$\$5,000 \text{ (Original Bill)} - \$2,000 \text{ (New Bill)} = \$3,000 \text{ (Total Reduction)}$

$\$3,000 \text{ (Total Reduction)} \times 25\% \text{ (Our Rate)} = \750.00 (Our Fee)

Our Agreement
